15. As per the karnataka Education Act 1983 the Institution shall posses furniture, curricula, library, and other facilities within one year and building and playground within three years.
16. This Institution must follow the School timings and working days as per the Department rules.
17. This Education Institution must intimate school opening and admission of students within 02 months of commencement of school. If the School is not commenced in time or violate any rules this registration will be cancelled voluntarily.
18. Already If there is Kannada medium from 6<sup>th</sup> to 8<sup>th</sup> standard, the provision of the English medium upper primary school will not able to make any way for kannada medium classes.
19. As per the Government order No. ED 27 SEP 2003 dated: 13.02.2003 the Institution must follow said rules and compulsarily maintian the service registers of the appionted employees.

21. Strength of the students in each class shall not exceed 50.
